Effective July 31, 2019 INDIGO RESOURCES LLC (INDIGO RESOURCES) and INDIGO HAYNESVILLE LLC (INDIGO HAYNESVILLE) merged with INDIGO MINERALS LLC ("Indigo").

Beginning in August, Indigo will now issue all revenue checks and JIB invoices out of INDIGO MINERALS LLC. If you previously received multiple checks from Indigo entities you will now only receive one.

Revenue Checks:

As a reminder, **Indigo has a minimum check disbursement amount of \$100; Indigo will accumulate revenues until this threshold is reached, and will disburse funds on the next check. For amounts less than \$100, annual payments are made each year.** For your security, we do not give the amount of any check over the phone.

If you are currently signed up for Direct Deposit with INDIGO RESOURCES LLC (INDIGO RESOURCES) and/or INDIGO HAYNESVILLE LLC (INDIGO HAYNESVILLE) you will continue to receive your payments via Direct Deposit once Indigo begins making payments. **No action is required.**

If you have NOT signed up for Direct Deposit, you may do so by completing the attached Direct Deposit Authorization form and return to Indigo.
